

Agricultural Waste Return/Transfer Agreement

(Anaerobic Digester Digestate)

1. Purpose

Use this form if you:

- Are a dairy operating an Anaerobic Digester ("AD"), or are receiving digestate from an AD; and
- Intend to return or transfer agricultural waste (i.e., AD digestate, solid manure or bedding produced from digested manure solids) to:
 - another licensed dairy; or
 - a farm field owned by another, but is included in your Dairy Nutrient Management Plan ("DNMP"); and
- Must account for the return or transfer in order to develop or update your DNMP.

Legal Disclaimer: This form is to be used for the limited purposes of developing, updating and implementing your DNMP, including transferring digestate in a manner consistent with Chapter 70.95.330(4) RCW. There are no representations either made or intended regarding its suitability for any other purpose. You should consult an attorney regarding your intended transfer of agricultural waste and the desirability of a more comprehensive agreement defining your legal relationship with the Importer.

2. Background

All dairies in Whatcom County are subject to regulation by the following federal, state or local laws:

- Federal Clean Water Act (Title 33 USC Sec. 1251 et seq.),
- State Livestock Nutrient Management Act (Chapter 90.64 et seq. RCW),
- State Water Pollution Control Act (Chapter 90.48 et seq. RCW),
- Whatcom County Critical Areas Ordinance (WCC Sec.16.16 et seq.)

Additionally, an AD must comply with Chapter 70.95 RCW in order to maintain an exemption from a solid waste permitting requirement. That law requires that all digestate be managed in accordance with a DNMP under Chapter 90.64 RCW that includes elements addressing management and use of digestate. This form facilitates the transfer and management of digestate consistent with these two statutory mandates.
